

Sydney is a senior attending Calistoga High School. She enjoys reading, writing, baking, watching a good movie, playing volleyball, and spending time with family and friends.






Second Prize Winner: Delana Miller Title: "The Gems of the Valley" Medium: Ceramic

In compliance with the provisions of Section 2279 of the California Food and Agricultural Code, I hereunder submit this report of the agricultural production for Napa County for calendar year 2009. This report deals with the gross value of production and does not attempt to reflect net farm income or cost of production and marketing.

Gross value of all production was \$502,236,581 – an increase of \$92,970,541 from 2008. This 22.7% increase in gross value was primarily due to an increase in winegrape production. The total value of the winegrape crop was up 23.8% (\$95,105,645), while overall production increased by 27,111 tons, or 23.4%. Floral and nursery crops registered a decrease of 32.1% in value, from \$3,347,700 in 2008 to \$2,272,755 in 2009.

This year's crop report is dedicated to Deputy Ag Commissioner Vicki Kemmerer, who retired in December of 2009 after 20 years of service to Napa County. Among many other duties, Vicki was responsible for overseeing the production of this annual crop report. Her dedication and guiding spirit have set a very high standard for all of us to emulate. She will be greatly missed by her co-workers as well as by members of the agricultural community. Please turn to the centerfold of this report for more highlights and pictures of Vicki's career.

I would like to thank my staff who worked hard to create this report and also to express our appreciation to the producers, processors, government agencies and others who contributed this vital information. Without such a collaborative effort, this report would not be possible.



#### Vicki Kemmerer Retires After a Long and Productive Career

Vicki Kemmerer retired from the Napa County Department of Agriculture in December of 2009 after more than 20 years of service. She began her career with Napa County in 1989 as an Agricultural Biologist assigned to the pesticide use enforcement program. Vicki played an integral role in the launch of the 100% pesticide use reporting program in 1990 and with the development of early computer programs for pesticide permitting and use reporting.


In 1996, she was promoted to Deputy Agricultural Commissioner to oversee the pesticide use enforcement program. Her strong support of the Hands-On Training program, which started in 1994, exemplified her passion for making sure people and the environment were protected from any adverse effects from pesticides. Working with other staff members, she helped lay the foundation for the many current training sessions that provide valuable information to both English and Spanish-speaking members of the county's agricultural industry. Vicki also provided direction to department staff in publishing the first *Ag Rag* newsletter in 1998.

In 2003, Vicki assumed responsibility for the Pest Detection and Exclusion programs. She directed staff to implement the state mandated insect trapping program and also managed the weed eradication and control programs. She spearheaded work on the Light Brown Apple Moth quarantine program and began to develop efforts on the European Grapevine Moth project prior to her retirement. In 2004, her work to improve the quality of the annual *Napa County Crop Report* led to the crop report cover contest open to all Napa County middle and high school students. The contest, now in its sixth year, was the result of cooperation between the Ag Department and Napa County Farm Bureau's "Ag in the Classroom" program.

Vicki was known for her computer skills, and she was always eager to help her fellow staff members. She was the "go to" person if you needed help with a spreadsheet or teasing out valuable information from our pesticide use permitting database.

Vicki was passionate about her work and compassionate towards her fellow staff members and their kids. She was known to set little treats on her workmates' desks during holidays throughout the year, and she organized many staff social events, including her famous latke breakfasts and yearly holiday food drive. Her great compassion for pets of all kinds led to several dog rescue trips in which she legally brought pets from developing countries and found caring homes for them here in this country.







### **2009 Agricultural Crop Report**

The Napa County Agricultural Commissioner's mandate to protect agriculture is demonstrated through several important programs. Following are highlights of the work performed during 2009.

#### **EXCLUSION – NURSERY AND INCOMING SHIPMENT INSPECTIONS**

The Glassy-winged Sharpshooter (GWSS) spreads the bacterium *Xylella fastidiosa*, which causes the deadly Pierce's disease in grapevines, so exclusion of the pest from Napa County is a top priority. To that end, we inspect all incoming nursery shipments, whether or not they originate from known GWSS-infested areas. Out-of-state shipments which might harbor other pests of economic importance may be sealed or tagged at the state border. Our office is notified first by the border station and eventually by the owner of the shipment upon receipt. We then visit the delivery site to inspect the shipment.

#### **ERADICATION – WEED ERADICATION PROGRAM**

Rush Skeleton Weed was first identified over two decades ago at a single location in Napa County. Since then, we have discovered and eradicated two other smaller infestations, but we are still battling the original find and a newer satellite infestation.

#### **DETECTION – SURVEY PROGRAM**

One part of our Sudden Oak Death (SOD) program involves surveying for symptomatic vegetation in our wild lands. Suspect plant tissue samples are submitted to the California Department of Food and Agriculture lab for confirmation.

Vine Mealybug (VMB), a serious pest of winegrapes continues to spread in Napa County. New finds are also confirmed by the state lab. We are still very committed to working with local growers to find ways to eliminate damage caused by VMB.

#### **PEST DETECTION – TRAPPING PROGRAM**

In partnership with the state for many years, Napa County has deployed and monitored traps for the following insect species of economic importance: Glassy-winged Sharpshooter, Vine Mealybug, Western Grapeleaf Skeletonizer, Gypsy Moth, Light Brown Apple Moth, Japanese Beetle, Mediterranean Fruit Fly, Melon Fly, Oriental Fruit Fly, and other exotic fruit flies. An extensive cropland trapping program for European Grapevine Moth (EGVM) was initiated in October of 2009 after its presence was confirmed in several local vineyards – the first ever documented finds in North America. EGVM poses a very significant threat to our winegrape industry.

#### WEED AND INSECT BIOCONTROL PROGRAMS

An active biocontrol program has been established to deal with many common pests. Biocontrol agents are natural enemies that are introduced into the environment to lower pest population levels.
