In compliance with the provisions of Section 2279 of the California Food and Agriculture Code, I respectfully submit this report of the agricultural production for the City and County of San Francisco for the calendar year 2004. This report reflects only gross value of production and does not indicate net farm income or cost of production and marketing.

This report is part of a larger City and County Food and Agriculture report that will more thoroughly review food systems activities and issues. The larger report, *San Francisco Food Systems Food and Agriculture Report Card*, will reflect not only production issues that concern the City and County, but also examine distribution, consumption and recycling matters in order to facilitate more effective and sustainable food systems policies and programs that are meaningful for our diverse communities. This report card will be issued in the summer of 2005.

During last fiscal year, the Mayor's Office with the Board of Supervisors dissolved the Department of Consumer Assurances which housed the Agriculture and Weights and Measures Programs. Currently, these programs are in the process of being integrated into the Department of Public Health's Occupational and Environmental Health Section. During this transition, all agriculture standards, regulatory compliance and enforcement activities have remained intact. We continue to appreciate the patience and understanding from State and local agencies regarding all reporting procedures. This agricultural production report was diligently compiled by our Agriculture Biologists with contributions from City and County producers, processors, and government agencies.
