It is my pleasure to submit the 2011 Kern County Agricultural Crop Report. This annual report presents statistical information on acreage, yield and gross values of Kern County agricultural products in accordance with Sections 2272 and 2279 of the Food and Agricultural Code. The figures in this report represent only gross values and do not take into account the costs of production, marketing, transportation, or other ancillary costs. No attempt is made to reflect net income or loss to the producers of these commodities.

Kern County Agriculture has reached a milestone in 2011 by topping the \$5 billion dollar gross production value for the first time ever. The 2011 gross value of all agricultural commodities produced in Kern County is \$5,364,538,600. This represents an increase (12.8%) from the revised 2010 crop value (\$4,757,416,700).

The major factors affecting the increase in total value from the 2010 crop year were an 8.8% increase in total harvested acreage in the county, significant increases in Field Crop acreages and prices, increases in the price of Cattle, and increases in overall milk production coupled with significantly higher prices.

The top five commodities for 2011 were Milk, Almonds, Grapes, Citrus and Carrots, which make up more than \$3.1 Billion (70%) of the Total Value; with the top twenty commodities making up more than 94% of the Total Value.






