

Plant Protection and Quarantine









Regulated Articles:

- Nursery stock
- Cut flowers, garlands, wreaths or greenery of any plants
- Cut trees and shrubs, such as Christmas trees
- Green waste
- Fruits and vegetables (except as indicated on the attached list of exempted commodities)
- Bulk fresh herbs and spices (except as indicated on the attached list of exempted commodities)
- Any other products, articles, or means of conveyance of any character whatsoever, when it is determined by an inspector that they present a hazard of spread of LBAM.



Compliance Agreements

- All producers and handlers of LBAM host material within quarantine must enter into a Compliance Agreement to move product
- Compliance Agreements set-forth:
 - Conditions for movement outside any regulated area
 - Frequency of inspections and trapping protocols
 - Requirement for integrated pest management (IPM)
 - Conditions for prescribed treatments in any LBAM life-form detected during inspections


Regulatory Inspection Overview

- Nursery Inspections
 - Floriculture
 - Ornamentals
- Commodity Inspections
 - Field Inspections
 - Coolers / Processors / Packers





Suspect Laboratory Results Trigger Regulatory Treatment



- "Non-target"
 - Release hold & resume Inspection frequency
- "Consistent with *Epiphyas* postvittana"
 - Full-Hold on Premises
 - Nothing Moves
 - Regulatory Treatment is REQUIRED
 - Inventory of <u>All</u> plants:
 - If not treated and moved off site violations are issued



Treatment Targets Larvae and Eggs

- Regulatory Treatment:
 - Approved pesticide at quarantine approved rate
 - Oil at minimum of 1% volume
- Common Examples:
 - Proven efficacious against LBAM







Monitoring Treatments

- All aspects are monitored (Mixing/Application)
 - Must be within Regulatory Treatment Parameters
 - Dilution
 - Product proven efficacious against LBAM
 - Ensure full-coverage to run-off
- Dilution rates
 - Must meet program defined rates per pesticide
- Weather dependent
 - Leaves must be dry at application
 - Pesticide must be dry after application

Post-Treatment Inspection

- 100% Inspection of <u>All</u> treated plants
- Negative findings
 - Release Hold
 - Back to regular inspection frequency
- Suspect LBAM
 - Quarantine infested lots
 - Retreat infested lots only
